The Femicide Watch initiative aims to focus on femicide prevention through the collection of comparable data on femicide rates at national, regional and global levels. Building an online global database Since 2016, each November, in advance of the International Day on the Elimination of Discrimination against Women, the Special Rapporteur has called on different stakeholders including States, National Human Rights Institutions, civil society, as well as members of academia to submit data on gender based killings and femicide. On that date, the Special Rapporteur called All countries to establish an observatory of Femicide or an observatory of Femicide to document the murders related to the women's GENERO they charged, analyzed and revised data on femicides with the objective of the prevention. This report contains critical information that is based on the foregoing and continuous work on femicide in Canada and internationally by highlighting current and emerging trends and issues that require greater investigation and monitoring in the next few years. 'Source: Canadian Femicide Observatory for Justice and Responsibility' 'The Canadian Femicide Observatory of Justice and Responsibility' (CFCJA) is the only Canadian initiative that responds to the United Nations calls to establish femicide observatories to document, understand and document with precision the murders related to the GENERO of women and children or 'femicide'. The report of the meeting asks all countries to "rent multidisciplinary national agencies, as" femicide clock "with the objective of actively working on the prevention of femicide or murders related to women's GENERO (ECE / AC. 28/09/2, Annex I). In its declaration to the high-level meeting on the fifth anniversary of the Fourth World Conference on Women on October 1, 2020, the UN Secretary-General asked the Affirmative action to prevent violence against women, including Femicide. The CFCJA mandate is to establish a visible and national approach in femicide in Canada through (1) document feminal as they occur in Canada; and (2) monitoring The state, legal and social responses to these murders. For example, in March 2019, the Follow-up Mechanism to the Belo Horizonte Convention (MESECV) adopted the Model Law on the Prevention, Punishment and Eradication of the Gender-Related Killing of Women and Girls (Femicide/Femocide) (English | Spanish | Arabic). The Beijing+25 regional review, organized by the United Nations Economic Commission for Europe in October 2019, also supports the Special Rapporteur's initiative. In the context of the Covid-19 pandemic, Ms. Simonovic presented a report to the General Assembly on 9 October 2020 (A/75/144), on the intersection between the Covid-19 pandemic and the pandemic of gender based violence against women, in which she highlights the dramatic increase globally in cases of domestic violence. While national prevention systems often lack reliable data in so-called 'normal' times, the current Covid-19 context has made it even more difficult to get a clear picture of the gender-based violence against women and girls killed by violence in Canada from January 1 to November 30, 2019.
